

With BizRadar, a firm can organize and condense large volumes of unstructured data, i.e. a firm's time, billing, and accounting transactions into reports and charts that help develop solutions for today's complex business problems. BizRadar also helps answer a wide range of questions geared towards increasing revenue and profits. These questions may include:

When and how much to raise client rates without losing them?

When and how much to raise timekeeper and rainmaker performance based compensation?

To answer these and other questions, the BizRadar server compresses the firm's historical data into a consolidated statistical data model.

- **Consolidation** involves the aggregation of data that is accumulated and associated with one or more of a firm's business entities. For example, billing and collection transactions may be rolled up to a managing attorney and/or practice area, which in turn may be rolled up to a firm data model for anticipating billing and collection trends.
- **BizRadar® dashboards** support drill-down of the consolidated data, i.e. a technique that allows users to navigate through data models by drilling down from a given entity to and through others to see breakdowns and detail. For instance, users might drill-down billing and collections by attorney then by practice area or the reverse to study the billing and collections from different points of view.

A big advantage of dashboards (as opposed to printed reports) is the way they provide quick visual insights for detecting and solving problems. Strategically, BizRadar dashboards help administrators gauge how well the firm is doing as a whole, in addition to identifying top producers; they can also see which attorneys and which clients are actually contributing to profits and other Key Performance Measures (KPM).
